## Application Process & Important MDDSC membership Information

In case your company is not a member of EuroCham yet, we kindly ask you to proceed with the application for membership to EuroCham, which is a prerequisite to becoming a member of the MDDSC.

Once your Company has become a member of EuroCham and the MDDSC, we expect your Company representatives to comply with EuroCham's Statutes and EuroCham's Sector Committee Rules and Regulations, which are available on the EuroCham website to apply.

Please note that for a company to be eligible for membership in MDDSC, a company must meet the following two criteria:

1. Be a foreign company, i.e., one in which non–Vietnamese persons or entities own a majority of the company's shares [Note: If the applicant has a parent company, the parent company must also be a foreign company]
2. Either
  - a. Have a worldwide consolidated Medical Devices and Diagnostics revenue of more than USD 100 Million yearly; or
  - b. Be a Vietnam–licensed enterprise, wholly owned by foreign investors (a “Wholly Foreign-Owned Enterprise” or “WFOE”) with an approved license to work with Medical Devices and Diagnostics products in Vietnam and representing at least one international Medical Devices and Diagnostics company meeting the requirements of (a) above.

“Medical Devices and Diagnostics products” shall follow the definition of the World Health Organization as below:

“Medical device” means any instrument, apparatus, implement, machine, appliance, implant, reagent for in vitro use, software, material or another similar or related article, intended by the manufacturer to be used, alone or in combination, for human beings, for one or more of the specific medical purpose(s) of:

- diagnosis, prevention, monitoring, treatment or alleviation of disease,
- diagnosis, monitoring, treatment, alleviation of or compensation for an injury,
- investigation, replacement, modification, or support of the anatomy or a physiological process,
- supporting or sustaining life,

- control of conception,
- disinfection of medical devices
- providing information by means of in vitro examination of specimens derived from the human body;

and does not achieve its primary intended action by pharmacological, immunological or metabolic means, in or on the human body, but which may be assisted in its intended function by such mean”

The annual membership fee of MDDSC is defined prior to the beginning of each calendar year by the decision of the MDDSC Executive Board based on planned activities, related expenses, and other available sources of funds. It shall remain reasonable and in the range of accepted standards. It is fixed for the calendar year 2022 at 2000 USD.

Upon receipt of a complete application packet, your application will be reviewed by the Executive Board members of MDDSC. All eligible applications will be voted on at the next Executive Board meeting (provided there are at least two weeks between the date of submission and the meeting). Applicants become MDDSC members if they fulfill the selection criteria defined above and if two-thirds (2/3) of the General Assembly vote in favor of the measure.

An applicant should expect to receive a written decision from the EuroCham Secretariat within two weeks of the General Assembly vote.
