#### FOREIGN EMPLOYMENT SURVEY

Conducted by Human Resources Sub-group Vietnam Business Forum

Vietnam Business Forum has conducted a survey with over 83 companies from Foreign Business Associations and Chambers of Commerce in Vietnam responding a set of questions which we believe will be reflective on the trends on employment of Foreign Nationals in Vietnam which are formally employed.


Respondents consisted of Fortune 500 companies in banking, manufacturing, production and FMCGs

#### **Summary of survey**

- 50% of companies responding employ up to 5 Foreign Nationals in their company
- Technical expertise and shortage of qualified Vietnamese candidates are the two main reasons for employing foreign nationals in Vietnam
- 62% of Foreign Nationals employed are on the Board of Directors or Heads of Department
- Majority are employed in General Management and technical departments
- 60% are employed in Vietnam for between 3 5 years
- 46% have worked for the company for between 3 5 years
- 93% of Foreign Nationals employed have over 3 years experience in their role
- 54% of Foreign Nationals have been in their current role for over 3 years
- 93% of Foreign Nationals are employed for longer than 2 years in Vietnam
- 56% Foreign Nationals are employed due to shortage of local candidates for positions or lack of technical skills experience
- 100% of work permits once full submitted to DOLSA take longer than 3 weeks to obtain
- 87% of respondents required work permit for a minimum of 1 5 years
- 71% of respondents have Foreign Nationals working in Vietnam for less than 3 months
- 55% of respondents are expecting to hire more than 4 employees in the next 5 years
- 26% of respondents ideally wants that documents need only to be notarized or certified and then authenticated or endorsed by the State Department or Foreign Affairs Office of the Country of Origin
- 13% would ideally like an conditional work permit for 6 months once documentation being obtained






### 3. At what company level and department do you employ Foreign Nationals?




## 5. What is the average length of service of Foreign Nationals employees in your company in Vietnam?


## 6. What is the average length of service of Foreign Nationals employees in your company in worldwide?


## 7. What is the average year of experience of Foreign Nationals employees in their current position?


### 8. What is the average time in current position of Foreign Nationals employees?


# 9. What is the average length of employment for Foreign Nationals employees in your company?




## 11. What is average lengthen of time to get a Work Permit for your Foreign Nationals employees once full documentation submitted to DOLISA?


## 12. What length of duration of work permit would you like to have in Vietnam for your Foreign Nationals employees?


### 13. How many Foreign National employees a year do you have coming to Vietnam to perform work less than 3 months


### 14. How many Foreign Nationals employees you are going to employee in the next 5 years?
