Vietnam releases Personal Data Protection (PDP) Draft Decree

More than two years after the announcement of the plan for a Personal Data Protection legislation, the Ministry of Public Security has released a full draft of its personal data protection decree for public consultation.

While it is encouraging to observe many concepts, principles and PDP regime are borrowed from the EU's General Data Protection Regulation (GDPR), Vietnam plans to introduce deviations from several key concepts and provisions of the GDPR and proposes restrictions on personal data processing and transfer. We thank Digital Sector Committee member Mr. Bruno Sivanandan, and Vice-Chair Ms. Ha Nguyen for contributing to EuroCham's webinar sharing their perspectives on the draft with EuroCham members, and leading EuroCham's Personal Data Protection taskforce coordinating inputs from members to share international practice information, to make responsible recommendations to the Vietnamese Government to achieve a PDP legislation that will be in sync with international norms, including those of GDPR.
