EuroCham Vietnam and Ministry of Foreign Affairs co-hosted "Meet Europe 2021: EU-Vietnam Partnership Post-Covid and Whitebook Launch". The hybrid launch, livestreaming from Meliá Hanoi Hotel in Hanoi, brought together more than 150 political and business leaders to discuss how government and the private sector can work together to boost EU-Vietnam trade and investment in the post-pandemic new normal

Chairman Bruno Sivanandan on behalf of Digital Sector Committee's members gave a speech at this landmark event, including recommendations on: (1) Government platform: to recommend the Government partner with the private sector to build cloud computing for government agencies, to adopt smart cloud first policies and to reduce the cost by adopting internationally recognized cloud accreditation,



compliance and security mechanisms; (2) Free flows and exchange of data between Vietnamese businesses and multinational, international business partners; (3) Right to privacy for all: applaud the Government for consulting with the international business community on the Personal Data Protection Decree and we welcome further consultation opportunities to ensure the final Decree will align with GDPR and other international privacy laws to protect both Vietnamese users and European businesses.

Comment on Draft Decree on Administrative penalty in Cyber Security

Digital Sector Committee thanks the Ministry of Public Security (MPS) for making the draft decree available for public consultation. It is our understanding the Draft Cybersecurity Sanction Decree is intended to cover sanctions and remedial measures under the Law on Cybersecurity ("LOCS"), the decree implementing LOCS ("LOCS Implementing Decree"), and the Decree on Personal Data Protection ("PDP Decree"). We would like to highlight that both PDP Decree and LOCS Implementing Decree are still pending, and the MPS has not yet made the latest drafts available. It is therefore difficult for industry to provide meaningful comments on this Draft Decree. The Draft Decree introduces expansive new concepts and terms that have not been seen before, especially in those provisions relating to personal data protection (e.g. in Article 14 re: General Principles on data protection and Article 15 - Violating rights of data subjects). It appears that there have been significant changes to the PDP Decree compared to the version released to the public in February 2021. Industry comments are more appropriately directed towards the underlying decrees which set out the substantive obligations, not to a sanctions decree.

Digital Sector Committee respectfully requested that: (1) The Government release the latest draft of the PDP and LOCS Implementing Decrees and provide an appropriate period for industry consultation; and (2) The public consultation of this draft decree be extended to align with the issuance of the draft PDP and LOCS decrees. (3) The timeline for implementation of this decree be extended, to provide an appropriate transition period for companies to implement the "base" PDP and LOCS decrees, as these have not even been issued yet. The sanctions decree should only come into force after there has been sufficient consultation of the PDP and LOCS decrees, and sufficient transition time has been provided to companies to implement the PDP and LOCS decrees. It is otherwise challenging for companies to be subject to these sanctions prior to knowing what the requirements of the "base" decrees contain.

Comment on Draft Circular Amending and Supplementing E-commerce Activities

The Draft Circular amending and supplementing a number of articles of the Circular No. 47/2014/TT-BCT dated December 5, 2014 of the Ministry of Industry and Trade, providing for the management of e-commerce websites and information. Circular No. 59/2015/TT-BCT dated December 31, 2015 of the Ministry of Industry and Trade providing for the management of e-commerce activities via applications on mobile devices. Digital Sector Committee recommended revising Article 5 of Circular 47 as follows: "Article 5. Principles of notification and registration of e-commerce websites:

- 1. Owners of sales e-commerce websites should make notification to the Ministry of Industry and Trade according to the provisions set out in Section 1, Chapter II of this Circular.
- 2. E-commerce service providers must register with the Ministry of Industry and Trade according to the provisions set out in Section 2, Chapter II of this Circular.
- 3. Traders and organizations that own e-commerce websites that have both sales and e-commerce service functions shall only carry out registration procedures with the Ministry of Industry and Trade according to the provisions of Chapter II of this Circular."
